## ROAD CLOSURES

#### Station Street – 24/25 & 28/29 Feb CLOSED 7pm to 6am.

The road will be closed from the High Street exit down to Lansdown Place, so UK Power Networks can carry out new service connection works.

**Diversion**: U5122 Southover Road – U5162 Southover High Street – B2193 Southover High Street – C7 Bell Lane – C7 Winterbourne Hollow – A277 Western Road – A277 High Street In both directions.

#### Cuilfail Tunnel – 6 March | CLOSED 8pm to 6am.

The tunnel will be closed to be cleaned, CCTV cameras installed, tunnel lighting replaced with more energy efficient LEDs, and replacing of fire hydrants. **Diversion:** signposted on site.

#### INCREASED ON-STREET PARKING CHARGES

Lewes Chamber of Commerce is very disappointed that East Sussex County Council has decided to alienate businesses, shoppers, and tourists to the town, by significantly increasing charges for on-street parking.

Lewes businesses, especially small and independent retailers, throughout the town already have a tough enough time, with high rent and rate charges, plus the already restricted parking; this increase will further discourage people from coming to the town to shop, or visit the many attractions.

We are hoping to open a dialogue with ESCC on this matter and will report back in due course.

#### NORTH STREET QUARTER UPDATE

Lewes Chamber of Commerce has a seat on the North Street Quarter sounding board, where we are updated on what is happening. The latest information is as follows:

North Street Quarter was put out to market last year which resulted in a number of bids from potential developers. The landowners – Lewes District Council and North Street Quarter Ltd – are now in the process of confirming that the preferred partner has a demonstrable track record of delivering sites of this complexity. It is intended that contracts will be exchanged as soon as possible.

Meanwhile, two further planning applications were submitted to the South Downs National Park Authority at the end of last year. The first of these dealt with a minor design amendment (an alteration to the link blocks in Papermill Court). This has been approved by the planning authority. The second application is to discharge the pre-commencement conditions for phases 2 and 3. This is on track to be approved in the next few weeks.
